STADIUM USE REGULATIONS COMO MUNICIPAL STADIUM "GIUSEPPE SINIGAGLIA"

(Former art. 19-ter, par. 3, lett. c. of the decree of the Ministry of the Interior of 18 March 1996, as amended by the decree of the Ministry of the Interior of 6 June 2005 concerning "Modifications and integrations to the decree of the Ministry of the Interior of 18 March 1996, concerning "Safety rules for the construction and operation of sports facilities" and former art. 4. par. 2 of the decree of the Ministry of the Interior of 6 June 2005 concerning "Procedures for the issue, distribution, sale and transfer of admission tickets to sports facilities with a capacity exceeding 10,000 seats, on the occasion of the holding of competitions concerning the game of football", Legislative Decree No. 8 of 8 February 2007, Decree of the Ministry of the Interior of 8 August 2007, Determination No. 14/2010 of 17 March 2010).



Access to and stay, for whatever reason, inside the sports facility, during football matches, are regulated by the 'rules of use' and the 'code of ethics'.

Failure to comply with them will result in the immediate termination of the service contract, with the subsequent removal of the offender from the venue, as well as the application of the provisions and sanctions provided for by the regulations in force, including the application of the prohibition of access to venues where sporting events are held (DASPO) and/or the approval mechanism.

1. In particular, the following provisions are recalled:

- a. the purchase of the admission ticket implies the acceptance and acknowledgement of the "regulations for use" and the "code of ethics". Likewise, it implies consent to the relevant regulations of the O.N.M.S., UEFA, the FIGC, the LNP and the PS authorities;
- b. admission tickets to the stadium are personal, named and numbered. It may not be transferred to third parties, except in the cases and in the manner provided for by the relevant legislation and by the club;
- c. For access to the stadium, the possession of a valid identity document is required, which must also be shown at the request of the stewards, in order to verify the correspondence between the holder of the admission ticket and the holder of the same (including minors). The presentation of the fidelity card is compulsory in accordance with the provisions of the competent authorities.
- d. the admission ticket must be retained until exiting the stadium;
- e. entry, as a rule, must be through the gate indicated on the purchase receipt;
- f. the spectator has the right/duty to occupy the assigned seat and, therefore, with the purchase of the admission ticket he/she undertakes not to occupy different seats, even if not used by others, unless expressly authorised by the company organising the event with the authorisation of the competent authorities;
- g. the spectator may be subjected, also by stewards and by means of metal detectors, to controls aimed at (pat down) preventing the introduction of illicit, prohibited and/or dangerous materials and is obliged to follow the instructions provided by the stewards (Ministerial Decree 28/07/2011).
- h. Custody of objects - stewards are not in charge of guarding any objects collected by them (helmets - lighters etc. etc.)

2. Inside the sports facility and the outdoor reserved area IS FORBIDDEN:

- a. Externalizing any form of racial, ethnic, territorial or religious discrimination or other manifestations of intolerance by chanting or displaying inscriptions;
- b. standing in the vicinity of passageways, exits, entrances, along access routes, escape routes and any other escape routes without a justified reason;
- c. climbing on balustrades, parapets, partitions and other structures not specifically intended for the parking of the public;
- d. damage or tamper with facilities, infrastructure and services of the facility in any way;
- e. introducing or possessing poisons, noxious substances, flammable or soiling materials and drugs;

- f. introducing or offering for sale alcoholic beverages with an alcoholic content of more than 5°, except for derogating authorisations for particular areas, issued by the competent authority, subject to a favourable opinion from the Questore;
- g. introduce or possess stones, knives, offensive or throwable objects, sound instruments, light-emitting systems (laser pointers) and other objects that may cause disturbance or danger to the safety of all persons present in the facility;
- h. introduce belts with large metal buckles and other accessories or aids that could endanger the safety of the event;
- i. introduce umbrellas, with the exception of those of a small size, in any case not having sharp points and of a shape and/or material that may endanger the safety of the event and the spectators;
- j. introduce crutches unless expressly authorised;
- k. displaying material which obstructs the visibility of other supporters or emergency signs or which otherwise obstructs escape routes to the playing area;
- l. engage in any kind of commercial activity that has not been authorised in advance;
- m. introduce and sell within the sports facility, drinks contained in cans, glass or plastic bottles;
- n. introduce animals of any kind, unless expressly authorised;
- o. introduce and/or wear bibs or clothing of the same or similar colour and design to those of stewards and other service personnel;
- p. to introduce and display banners, placards, horizontal banners, banderols, documents, drawings, printed or written material other than those explicitly authorised by the Gruppo Operativo per la Sicurezza (GOS) at the request of the sports club; they may not in any case be displayed in spaces other than those indicated by the sports club and must be removed at the end of the event;
- q. organising unauthorised choreographies or choreographies that differ from those authorised by the Gruppo Operativo per la Sicurezza (GOS) at the request of the sports club;
- r. accessing and remaining inside the facility in a state of intoxication or under the effect of narcotic or psychotropic substances.

By way of example, but not limited to, the following are the most common categories of objects that must NOT be brought into the area affected by the sports event:

Please note that the following conduct, in addition to being liable to a fine of 100 to 500 euros, as a breach of these regulations, may also constitute a criminal offence disguising, possessing one's own and improper weapons, displaying emblems or symbols of associations that spread discrimination or violence on racial, ethnic, national or religious grounds, incitement to violence during competitive competitions, possession, throwing and use of dangerous material and pyrotechnic devices, stepping over separators and pitch invasion.

Finally, it should be noted that the plant is controlled by an audio-visual recording system located both inside and outside, the data of which are processed by the owner of the plant in accordance with the provisions of the legislative decree of 30 June 2003, No. 196 and the Ministerial Decree of 06/06/2005.

Personal data is processed in accordance with the law.
